Collector coins issued by NBP are sold at NBP regional branches and in the NBP online shop.

In January 2022, Narodowy Bank Polski will be putting into circulation a gold coin with a face value of 200 złoty and a silver coin with a face value of 10 złoty – “Polish Olympic Team – Beijing 2022”.

Narodowy Bank Polski is the central bank of the State, responsible for its monetary policy and price stability. The Bank's functions are described in the Constitution of the Republic of Poland and the Act on NBP. NBP holds the exclusive right to issue the currency of the Republic of Poland. As the central bank, it does not provide accounts for the general public, accept deposits from or extend loans to individuals. It acts as a banker to the State budget and public sector entities. NBP also holds and manages the foreign exchange reserves of the State. Finally, it functions as a banker to banks, creating conditions for the operation of the Polish banking system. On 15 December 2021, Narodowy Bank Polski is putting into circulation a silver coin “We thank healthcare workers for their dedication during the COVID-19 pandemic”, with a face value of 10 złoty.

The first case of SARS-CoV-2 coronavirus infection was recorded at the end of 2019. In 2020, the virus spread almost all over the world, and the World Health Organization declared a pandemic. Many people have lost their lives after being infected with the new virus. The COVID-19 pandemic has also caused global social and economic chaos, including the largest global recession since the Great Depression. To counter the pandemic, swift and decisive action was needed.

Doctors, nurses, paramedics, pharmacists as well as other medical and support staff stood on the front lines of the fight against an unknown enemy, which grew stronger and more ruthless day by day. They are the ones who have been uninterruptedly waging war against the coronavirus for almost two years. Risking health and life, they have bravely fought for each patient.
