Press announcement from the meeting of the Commission for Banking Supervision (KNB) held on 9 February 2005

At its meeting on 9 February 2005, the Commission for Banking Supervision (KNB) authorised the acquisition by **Bank Handlowy w Warszawie SA** with headquarters in Warsaw, of an organised part of **ABN AMRO Bank (Polska) SA** with headquarters in Warsaw.
